

STATEMENT OF WORK

BACKGROUND

The Site is located at 7239-7267 Barkersville Road in Providence Township, New York. The emergency objective of this Task Order is to close all of the building openings and reduce the release of asbestos to the environment. The released asbestos can negatively impact the nearby residential community. A security fence will also be installed to limit unauthorized access to the property. Upon completion of these tasks, a Fair Opportunity Act Notice will be issued for the remaining Site tasks. Those tasks will focus on the abatement of asbestos waste within the building.

The purpose of this Task Order is to mitigate the threat of direct contact and off-site migration of asbestos waste.

TASKS TO BE PERFORMED:

The contractor shall furnish all necessary personnel, equipment and materials to perform the work as set forth below. Additional technical direction will be provided by the On-Scene Coordinator (OSC), through written daily work orders. The contractor shall conduct all operations in accordance with applicable local, state, and federal regulations.

1. Upon receipt of a task order, assign a Response Manager and immediately contact the On-Scene Coordinator (OSC) to discuss site operations, objectives, and schedule field activities. The OSC of record for this Site is Mr. Paul Kahn, who can be reached at (908) 420-4508.
2. Immediately install a security fence around the property to limit un-authorized Site access.
3. Seal all open pathways on the building to limit the release of asbestos waste..
4. Develop and implement site health and safety plan, quality assurance project plan, and community air monitoring plan.
5. Establish support zones, contaminant reduction zones, and exclusion zones.
6. Establish engineering controls to assure proper management of collected waste.

EPA considers some of the planned activities in this SOW to be subject to Construction Wage Rate Requirements (formerly known as the Davis Bacon Act) wages.
