During the next two week period, it is expected that: shoring slide rail components such as panels and spur posts for excavation of contaminated subsurface soil and water treatment train components such as a weir tank, storage tanks, filter media vessels, pipes and pumps for treatment of contaminated groundwater collected from excavations will arrive on-Site; all Site infrastructure features will be completed, including installation of construction BMPs, contaminated soil contaminated cells, and clean soil pad for storage of clean backfill material will be completed (excavation of contaminated subsurface soil will begin immediately thereafter); and decommissioning of certain groundwater treatment and/or monitoring wells, along with installation of new groundwater monitoring wells will be evaluated.
